IOWA DONOR NETWORK (IDN) OPERATES AS THE PRIMARY CONTACT FOR ORGAN, TISSUE AND EYE DONATION SERVICES IN THE STATE OF IOWA. THE CENTERS FOR MEDICARE AND MEDICAID SERVICES (CMS) HAS CERTIFIED IDN TO FUNCTION AS THE SINGLE ORGAN PROCUREMENT ORGANIZATION SERVING THE STATE OF IOWA. IDN ALSO PROVIDES TISSUE RECOVERY SERVICES. IN 2017, ORGAN RECOVERY SERVICES GENERATED \$11,745,443 IN REVENUES WHILE TISSUE RECOVERY SERVICES CONTRIBUTED \$6,530,790 TOWARD REVENUES. THROUGH REFERRAL CALLS FROM MORE THAN 120 IOWA HOSPITALS, MEDICAL EXAMINER OFFICES AND EMS AGENCIES, IDN EVALUATES OVER 10,000 PATIENT DEATHS PER YEAR FOR THE POTENTIAL FOR ORGAN AND TISSUE DONATION.
